## Camp Quality Privacy Policy

The collection and use of your personal information is governed by the [Personal Information Protection and Electronic Documents Act \(PIPEDA\)](#), Stats Can.2000, c.5.

Camp Quality will collect, use, and disclose your personal information through its database or from time to time through other means with your knowledge and consent, and only for the purposes that we have identified prior to or at the time we collect the information.

- To facilitate communication with you by Camp Quality.
- To assist in maintaining donor profiles.
- To assist in processing camper profiles.
- To assist in processing volunteer profiles.
- To assist in placing volunteers at an appropriate Camp or event.
- To advise you of changes to operational matters.

Except as otherwise set out herein, Camp Quality will not sell, trade, lend or otherwise voluntarily disclose to any third parties any personal information you have provided to us for any purpose not identified under this privacy statement provided that Camp Quality may share this information with legal and/or government bodies that reasonably require access to such information.

Camp Quality may also share your personal information with third-parties to assist in administering activities on its website, such as: for website administration and maintenance purposes; the administering of data processing; to professional advisors; or otherwise legitimate and reasonable purposes for which Camp Quality has obtained your consent or where consent can be reasonably implied.

In certain circumstances, Camp Quality may disclose your personal information to a government institution that has asserted authority to obtain this information.

Only authorized personnel shall have access to personal information and it will not be disclosed, without your prior written consent, for purposes other than those for which it was collected. Camp Quality has a designated Privacy Officer to ensure that the Privacy Policy guidelines are being followed by all staff and volunteers. Camp Quality will review and update Privacy Policy as needed to ensure ongoing information security and control.

By providing Camp Quality with your personal information, you are consenting to the collection, use, disclosure of your personal information in accordance with the principles that are outlined in this Privacy Policy.
